The MFB Foundation approved the impressive Mini-Grant application and Lamb Jam became a reality.

Nearly 200 people came to the Lewis & Clark County Fairgrounds in Helena August 25 to enjoy the culinary efforts of three chefs from the 320 Guest Ranch, Electric City Coffee and the Celtic Cowboy. Each chef created three dishes highlighting what makes lamb unique. Three judges rated the chefs' creations, and a People's Choice Award allowed the attendess to vote for their favorite dish.

Some of the delicious food included a Moroccan-style lamb chop; a lamb roulade, lamb merguez sausage slider and braised lamb shanks with rosemary.

Wool items, sheep's milk and sheep cheese were also showcased.

The event was sponsored not only by the MFB Foundation, but by the American Lamb Board, American Dorper Sheep Breeders Society and the Montana Wool Growers Association.

# MFBF comments on detrimental WOTUS

The Montana Farm Bureau has submitted comments to the Environmental Protection Agency urging a repeal of the 2015 Waters of the U.S. (WOTUS) for failure to achieve its stated goal of providing certainty and consistency. MFBF stated, "Unless repealed, the 2015 rule poses a serious threat to landowners' ability to use their land for farming and ranching."

The 2015 rule would allow regulators, and perhaps more concerning, citizen plaintiffs, to argue for seemingly limitless federal jurisdiction over lands used for farming and ranching, including, but not limited to, low-lying land features that retain only the slightest bit of water after a rain event or during snow melt, and isolated ponds, reservoirs and wetlands far removed from anything that could fairly be characterized as a navigable water.

The comments explained, "not only does such a rule fail to provide any of the clarity of predictability that was promised, it opens the door to an unprecedented expansion of federal authority that would create enormous regulatory burdens and increased costs (permits can be in the hundreds of thousands of dollars) for farmers, ranchers, and others who depend on their ability to work the land."

"Clean water is important to all farm and ranch families in Montana but the 2015 WOTUS rule goes far beyond Clean Water Act authority," the comments concluded.

#### Support the farm bill

The Montana Farm Bureau has been keeping close tabs on what's happening with the 2018 Farm Bill. They continue to support H.R. 2 as farm bill conferees hash out the details. MFBF hopes for a compromise bill, and is pleased Montana's Congressional Delegation supports H.R. 2.

#### Still talking trade, NAFTA

The Montana Farm Bureau, which has been extremely concerned about the effect of tariffs on farmers and ranchers, was pleased to see some movement in the renegotiation of the NAFTA agreement with regards to Mexico.

"The announcement that the U.S. and Mexico have come to a preliminary agreement is very encouraging," said Nicole Rolf,

Montana Farm Bureau National Affairs Director. "Mexico has become one of our major agriculture markets since the inception of NAFTA so securing those markets for the future is of utmost importance. We've been hearing for months now that an agreement was close with Mexico and that Canada would follow soon after. I certainly hope that proves true, as we'd like to see our markets to the north—Canada is our number-one trade partner—secured before harvest is completely over."

The American Farm Bureau Federation has been closely tracking the progress of trade talks between the two countries.

"This is the kind of trade news we have been waiting for. In a time when the U.S. economy is booming, our farmers have been left behind," noted American Farm Bureau President Zippy Duvall. "Open markets and good trade agreements will give American agriculture the opportunity to be a part of this booming economy. We need negotiators to convince Canadian officials that they, too, will benefit from a revised treaty. We are hopeful that the value of a continued and improved NAFTA for all will bring everyone back to the negotiating table."

Duvall said although Farm Bureau applauds the work with Mexico--and hopefully with Canada, there is still a lot of work to do outside of North America. "We need to resolve our trade issues with China to create better opportunities for American farmers and ranchers."

#### Ag Labor Bill long overdue for farmers, ranchers

The American Farm Bureau is supporting the Ag and Legal Workforce Act of 2018 which would replace the H-2A program with a new H-2C program, said AFBF's public policy managing director Paul Schlegel.

"The advantages of the new program are that it's open to all agriculture, it is less bureaucratic for farmers, it reduces unnecessary recruitment obligation, moves enforcement to USDA and takes it out of the Department of Labor," noted Schlegel. The other major aspect of the bill a mandated E-Verify system nationwide.

"There are things that we would like to see improved if we can do it. If you look at the policy our delegates have enunciated on what they want in a guest worker program, the bill comes very close to that," Schlegel said.


